

**Black Warrior Council, Scouting America**  
**RELEASE AND INDEMNIFICATION – AGES 10 - 17**

The undersigned, (whether one or more, the “User”), in consideration of admittance as requested by the undersigned to the shooting sports complex of the Black Warrior Council, Scouting America (hereinafter respectively and collectively referred to as “BWC”), on behalf of User, and User’s heirs, successors, and assigns, agrees to and hereby does release the BWC and the Scouting America, and their officers, employees, agents, contributors, financial supporters, sponsors, administrators, executors and assigns (hereinafter respectively and collectively referred to as “BSA”) from, and jointly and severally agree to indemnify and hold BSA harmless from and against, any and all liabilities, costs and expenses (including reasonable attorney’s fees and expenses of litigation) which they may jointly or severally incur in respect of any claim, suit or cause of action of whatever kind or nature arising from, related to or on account of any User’s presence at the BWC’s Camp Horne property, including but not limited to the shooting sports complex, including without limitation any such injury, loss or damage resulting from any failure to perform on the part of any person with whom BWC and BSA may have contracted for goods or services in connection with the shooting sports complex at its Camp Horne property, irrespective of any civil commotion, force majeure, acts of God or government, or otherwise; and the User further agrees to and hereby does release BWC and BSA from and jointly and severally agrees to indemnify and hold each of BWC and BSA harmless from and against, any and all liabilities, costs and expenses (including reasonable attorney’s fees and expenses of litigation) which they may jointly or severally incur to any person, User’s heirs, legal representatives or assigns, in respect of any claim, suit or cause of action of whatever kind or nature arising from, related to or on account of any personal injury, loss of health, death, financial loss or damage to property directly or indirectly sustained by such person, their heirs, legal representatives or assigns, as a result of the User’s action, series of actions, or failure to act while on the Camp Horne property or otherwise. The undersigned declares that User is 10 years of age or over and in good health and agrees that as a condition to the BWC and BSA providing access to the Camp Horne property, User will obey all applicable laws, written and oral rules, direction, practices and procedures whether with respect to safety, conduct or otherwise; and in recognition of the danger to which User is voluntarily subjected in connection while on the Camp Horne property hereby knowingly, freely and voluntarily assumes the risks and waives any rights or cause of action, of any kind whatsoever, arising out of or as a result of use of the Camp Horne property from which any liability may or could accrue to User, BWC, and BSA and covenants never to sue BWC or the BSA on account thereof. User acknowledges and agrees that no alcoholic beverages or drugs are permitted at the Camp Horne property, User has not ingested any alcoholic beverage nor drug nor substance that could impair User in any manner whatsoever; that User is experienced with the risks and rules of the Camp Horne property; that all guns must be left unloaded, breached or open except when User is in a safe position in a shooting pad; and that safety eye and ear protection will be worn by User at all times at the shooting sports complex at the Camp Horne property.
